Addendum

The following communication, received on 28 May 2020, is being circulated at the request of the Delegation of <u>The Separate Customs Territory of Taiwan, Penghu, Kinmen and Matsu</u>.

The amendment of the "Quarantine Requirements for the Importation of Deboned (chilled or frozen)
Beef from Paraguay" in relation to Article 8 (Appendix 4-4) of the "Quarantine Requirements for the Importation of Animals and Animal Products".

The Separate Customs Territory of Taiwan, Penghu, Kinmen and Matsu notified the draft amendment of the "Quarantine Requirements for the Importation of Deboned (chilled or frozen) Beef from Paraguay" in relation to Article 8 (Appendix 4-4) of the "Quarantine Requirements for the Importation of Animals and Animal Products" on 30 January 2020 (G/SPS/N/TPKM/521). The amendment was promulgated and became effective on 22 May 2020.
