Description of content: The main purpose of this amendment is to adjust the hierarchy of rules for some phytosanitary requirements in order to improve the regulatory framework of plant protection and quarantine. In this draft, five articles were added, 13 articles were revised, and eight articles were deleted. The deleted articles of this amendment were moved to "Plant Protection and Quarantine Act" (hereinafter referred to as "the Act") and the relevant regulations authorized by the Act. This draft moved the information required for initiating the pest risk assessment for plant or plant products that do not have historical trade record to the "Enforcement Rules on Plant Protection and Quarantine Act" from the current phytosanitary requirements. In addition, the draft clearly elucidated that the phytosanitary action will be taken for the pests that may cause damage and do not have occurrence record as described by ISPM No. 20. The importation of the biological control agent which was regulated by "Agro-pesticides Management Act" and used for agricultural purposes, was exempted from the adoption of the paragraph 1 of Article 15 of the Act. 7.
