#### Addendum

The following communication, received on 8 November 2016, is being circulated at the request of the Delegation of the <u>Separate Customs Territory of Taiwan</u>, <u>Penghu</u>, <u>Kinmen and Matsu</u>.

The amendment of the "Quarantine Requirements for the Importation of Plants and Plant Products"

The Separate Customs Territory of Taiwan, Penghu, Kinmen and Matsu proposed the amendment of the "Quarantine Requirements for the Importation of Plants and Plant Products" on 13 January 2016 (G/SPS/N/TPKM/382). The amendments regarding the regulated pest list and new quarantine requirements for the host plants or plant products of *Arabis mosaic virus* (*Nepovirus*), *Potato spindle tuber viroid*, and *Pepino mosaic virus* (*Potexvirus*) from infected areas will enter into force on 1 January 2017.

In addition, the amendment regarding the "Quarantine Requirements for the Importation of Wood" was promulgated and entered into force on 1 October 2016 and has been notified on 24 October 2016 (G/SPS/N/TPKM/398/Add.1).
